All the prosecutor shall scrutinize the Challans/ Reports U/S 173 Cr.P.C according to the attached scheduled with this order vide notification No. DIR (O& R)/PPD/7-31/2011-3944 dated 30/08/2022. They are directed to ensure timely submission of report 173 Cr.P.C. in the competent court. The concerned prosecutor shall issue the receipt of reports 173 Cr.P.C. at the time of receiving the same for scrutiny. If reports 173 Cr.P.C. are not submitted by concerned SHO within stipulated period, they shall write a letter in this respect to DPO through undersigned for proceedings against the delinquents. Furthermore, they are bound down for submission of 20% reports 173 Cr.P.C. scrutinized by them before the District Scrutiny committee which stands revived by the competent authority. They are further directed to obtain orders of all granted bail petitions and final judgment from the court, draw their opinion on the said order and then forward the same to District appeal committee Khanewal for filing of appeal /revision also on CFMS Cell. All the prosecutors and attached clerks are also directed to submit attested copies of judgments entailing punishment for life and death along with copies of their opinion on the judgments, copies of 9(5) & 9(7) and other relevant documents for onward transmission to the Provincial Appeal Committee, without any delay. Moreover, adverse outcome forms must reached this office timely. They are also directed to upload the prosecutorial work and the cases into CFMS on daily basis. All the junior clerks of District

Renewal shall work with the concerned prosecutors under their directions. All the junior clerk/officials of the District are further directed to submit monthly dairies / any information required by any office well in time to Mr. Javed Iqbal Junior Clerk /focal person.
